He has served on the USP Hazardous Drug Expert Panel since 2010. He is actively working with NABP and state boards of pharmacy to provide training to their sterile compounding inspectors. Eric served on the Expert Panel for ASHP Research & Education Foundation in the development of the 2015 Outsourcing Sterile Products Preparation Vendor Assessment Tool and ASHP's Insourcing Readiness Assessment Tool.

Patti is the author of Compounding Sterile Preparations: ASHP's Visual Guide to Chapter <797> video and Companion Guide, co-author of Assuring Continuous Compliance with Joint Commission Standards: A Pharmacy Guide, and author of The Chapter <800> Answer Book.

With over 500 invited presentations and 50 publications, she has special interests in promoting medication safety, compounding sterile preparations, accreditation, and regulatory issues.

Medical Cannabis: Clinical & Policy Considerations for Hospitals

Christine Roussel, PharmD, BCOP

Christine Roussel is Assistant Director of Pharmacy at Doylestown Hospital, Doylestown PA.

Dr. Roussel is a graduate of USciences' Philadelphia College of Pharmacy, with Bachelors of Science in Toxicology and Doctorate in Pharmacy. She is currently an Adjunct Assistant Professor at USciences and precepts pharmacy students from U Sciences, Temple, LECOM and MCPHS.

Dr. Roussel is a facilitator and content author for Medisca (LP3 Network), and provides continuing professional education for adults on Sterile, Non-Sterile and Hazardous Drug compounding, as well as serves as a pharmacy consultant specializing in compliance and compounding facility design. Dr. Roussel provides over 100 hours of continuing education to pharmacists, physicians, nurses and pharmacy technicians each year between her compounding and medical cannabis educational programs, not including the variety of educational talks she provides to the community.

She has authored several articles on occupational exposure to hazardous drugs and proper handling, as protecting healthcare providers DNA is her primary passion! Dr. Roussel actively participates in state and federal legislative matters with a focus on compounding, medical cannabis and occupational exposure to hazardous medications.

Previous positions and experience include Director of Pharmacy for OncoMed, a closed door oncology specialty pharmacy, Pharmacy Manager for Center One Cancer Center and years of various pharmacy experience at Einstein Medical Center in Philadelphia such neonatal and adult intensive care, surgical patient care and sterile product compounding. Dr. Roussel is the current Legislative chair of the Pennsylvania Society of Health System Pharmacy and is a member of American Society of Health System Pharmacy (ASHP), American Society of Cannabis Pharmacy (ASCPH), Hematology Oncology Pharmacist Association (HOPA), Pennsylvania Pharmacist Association (PPA) and National Association of Drug Diversion Investigators (NADDI).
